# **GENERAL INFORMATION**

**BROADMOOR BAPTIST CHURCH** is a duly qualified Louisiana corporation. Broadmoor operates under a biblical style of church policy and carries out its programs under a committee system. All officers of the church are elected annually by the church. All committees are made up of differing terms; however, all terms of longer than one year are subject to re-election the following year. Members of the Board of Directors who have served a full term may not be immediately re-elected but must remain off of the Board for a minimum of one (1) year.

Term Definition:

"Ex-Officio" is a term indicating that such person, because of the office he or she holds, has direct relationship to the work assignment of that Committee or Board. An "Ex-Officio" member is in no way less of a committee member than any other and has equal discussion and voting privileges. The Senior Pastor is an ex-officio member of all boards and committees; however, the Senior Pastor, at his discretion, may choose from the ministerial staff an ex-officio designee for any committee assignment. The Executive Pastor is an ex-officio member of all Committees and Board of Directors.

"Ad Hoc Committee" is a group with a specific assignment for an indefinite period of time. In some cases, the committee purpose may be to study some matter and bring recommendations based on the results of that study. The members of these committees are elected to serve for the life of the committee.

"Staff Representative" means that staff person(s) are assigned to Committees and Boards to serve as a liaison between the committee and the church staff. The Staff Representatives(s) have no voting power but are available for information to aid the committee or board in discussion and decisions.

An asterisk (\*) by the name means that this person is being asked to serve again on the same committee.
